1. As a government agency, Peñaranda Water District shall deal only with legitimate Security Agency which issue BIR-registered official receipts.
2. All entries shall be typewritten.
3. Quoted prices shall be inclusive of applicable taxes and shall be firm and valid for a period of at least thirty (30) days from the date of receipt of quotation & shall be binding upon the supplier within the period.
4. A valid Certificate of Tax Clearance must be submitted with the bid. The certificate must remain valid for at least thirty (30) days following the payment term.
5. The security agency shall begin carrying out the Services starting on January 01, 2025.
6. Warranty shall be for a period specified in the Contract.
7. PWD reserves the right to post-qualify any supplier and/or to reject any or all submitted quotations.
8. The contract shall be awarded to the lowest calculated responsive bid.

TECHNICAL REQUIREMENTS

1. SECURITY GUARDS:

- a) Must be at least high school graduate.
- b). At least twenty one (21) years of age and above.
- c) At least 5'4" tall.
- d) Must be physically and mentally fit (medical certificate attached), as indicated in a neuro-psychiatric clearance for PNP and DOH-accredited institution and confirmed by a physician of the corporation.
- e) Of good moral character and cleared by law enforcement or police agencies and other government offices issuing clearance for employment and without previous record of any conviction by final judgment of a criminal offence involving moral turpitude. Must possess honorable discharge documents, if with military background. Copies of clearance shall be furnished the Peñaranda Water District.
- f) Must be holder of Certificate of Training for Security Guards and other requirements of RA 5487 as amended. (Must be duly attached as part of Technical Requirements).
- g) Trained in safe handling of firearms with Certificate from PNP Accredited Training Center.
- h) Must maintain good grooming, preferably military haircut.

2. SECURITY AGENCIES:

- a) The Security Agency must be in business for at least two (2) years and still in operation.
- b) Must be registered with PHILGEPS.
- c) Must have a valid and current Regular License to Operate a Private Security Agency issued by the PNP-Supervisory Office for Security and Investigation Agencies (SOSIA); (Original/Certified True Copy).
